# Roy W. Brown Middle School TITLE I School Parent & Family Engagement Policy

    - Roy W. Brown Middle School will hold its Title 1 meeting after our Open House on Thursday, September 14, 2023, at 8:00pm in our auditorium. Parents whose children meet the criteria for the Title I programming are encouraged to attend.
    - Parents who are unable to attend the scheduled Title 1 meeting are encouraged to contact the building principal and/or guidance counselor at any time with ideas, questions, suggestions and input. This can take place as a phone conference, email, personal meetings, or any other appropriate option.
  - 2. Offer a flexible number of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, child care, or home visits, as such services relate to parent and family engagement;
    - Parent input regarding Title I program and services will be solicited during the Title I parent meeting and regularly scheduled Parents' Association meetings
    - Data on academic progress will be collected throughout the school year and presented to stakeholders on a regular basis, through building principal presentations at faculty and parent association meetings
    - Presentations will be shared via Google Slide and/or video conferencing at the request of the parent
  - 3. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs under this part, including the planning, review, and improvement of the school parent and family engagement policy;
    - Parent input regarding Title 1 program and services will be solicited during the Title 1 parent meeting
    - Parents of children who participate in the program are encouraged to contact the building principal and/or guidance counselor with any questions, concerns or suggestions they have regarding the Title 1 program and services at any time

- (A) Timely information about programs under this part;
- (B) A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels students are expected to meet regarding the challenging State academic standards; and
- (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible.
  - Encourage monitoring of our Infinite Campus online resource for attendance, grades and other school-related information
  - Provide and deliver quarterly progress reports, report cards and parent/teacher conferences
  - Share our Program of Studies on our school website
- 5. If the Annual School Plan (schoolwide program plan) is not satisfactory to the parents of participating children, submit any parent comments on the Annual School Plan (ASP) when the school makes the plan available to the local educational agency.
  - Parent input for the plan is shared at the Title 1 meeting and is relayed and taken into consideration in making revisions.
  - Parents may submit written refusal regarding participation in the Title 1 programming.

### D. Shared Responsibilities for High Student Academic Achievement-

As a component of the school-level parent and family engagement policy, each school shall jointly develop with parents for all children served under this part a school-parent compact that outlines how parents, the entire school staff, and students will share the responsibility for improved student academic achievement.

#### E. Building Capacity for Involvement-
